- **CALL TO ORDER**

- **APPROVAL OF MINUTES**

1. Minutes of the CACOFD Meeting held on May 9, 2024

**Motion to Approve May 9, 2024, Minutes: Moved by Member Fletcher, seconded by Member Washington. Motion carried unanimously.**
